

Refugee Resettlement And The Hijra To America

KEY POINTS:

- **Al-Hijra** is the Islamic Doctrine of Immigration. Mohammed instructed his followers to migrate and spread Islam and shariah law across the world in order to create an Islamic state.
- **Kinetic terrorists:** Arrests have already been made of Iraqi, Somali, Bosnian, and Uzbek Islamic terrorists who entered the US as refugees.
- **Migration Trumps Terrorism:** Islamic migration, from Iraq, Somalia, Syria, Burma, Uzbekistan, Bosnia and others, will have a greater negative impact on America's future cultural survival and security than kinetic terrorist attacks.
- **European Example:** Unchecked immigration leads to chaos created by the population explosion of shariah-loving migrants to that continent.
- **US State Department's Refugee Admissions Program (RAP)** is where most of the refugees bound for America are chosen by the UN High Commissioner for Refugees. The manner in which they are distributed to small towns and cities, their colonizing impact is greater than other forms of legal immigration.
- **The Problems with RAP:** RAP is 35 years old and has become an entrenched bureaucracy that operates secretly, is complicated for citizens to understand, is expensive for the US taxpayer and is unfair to towns and cities which shoulder the primary burden of caring for the mostly poor and uneducated 'refugees.'

- **Nine (9) major federal contractors are paid by the head to distribute refugees** to approximately 350 subcontractors in over 190 US cities and towns:
 - US Conference of Catholic Bishops
 - Lutheran Immigration and Refugee Service
 - Episcopal Migration Ministries
 - Hebrew Immigrant Aid Society
 - World Relief (Evangelicals)
 - Church World Service
 - US Committee for Refugees and Immigrants
 - International Rescue Committee
 - Ethiopian Community Development Council.

- **49 states resettle refugees.** An unfair burden is placed on certain states. E.g. Minnesota has received over 10,000 Somali refugees in ten years. States are expected to carry more costs as the federal government pays for less.

- **Refugees are eligible for all forms of welfare,** food stamps, subsidized housing and health care. Refugees thus have a greater impact than other legal immigrants might have on communities as they are resettled by the contractors in unsuspecting cities and towns.

- **What constitutes a ‘refugee’?** The Obama Administration is attempting to expand the definition of what constitutes a ‘refugee’ as they insist that the ‘Unaccompanied alien children’ invading our borders are refugees, and would thus be eligible for social services/welfare and for family reunification.

- **“Pockets of resistance”:** Some American cities are opposing the resettlement of refugees in the first place, or the placement of additional refugees where the city has already become overloaded.
